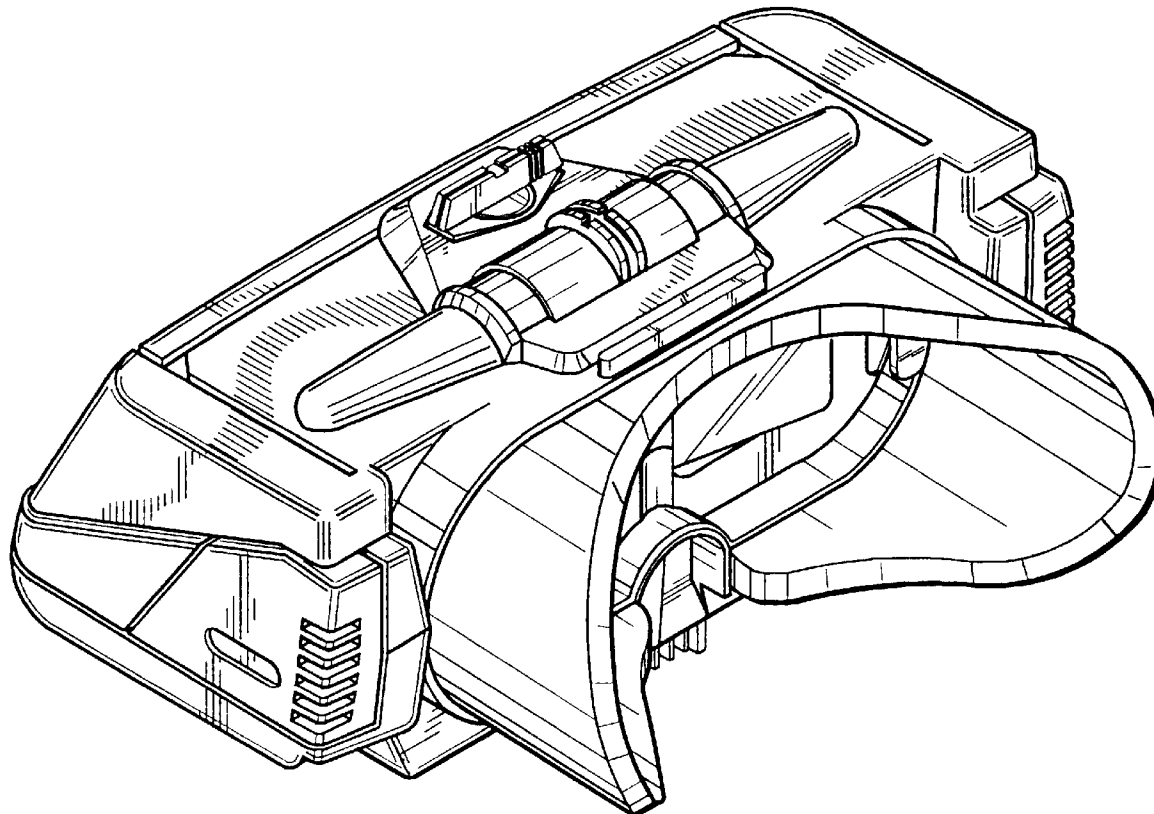
[57] CLAIM

The ornamental design for a “game machine,” as shown and described.

DESCRIPTION

FIG. 1 is a top right rear perspective of a game machine in accordance with a first embodiment of our new design; FIG. 2 is a top left front perspective of the embodiment shown in FIG. 1; FIG. 3 is a plan view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a left side elevation thereof; and FIG. 8 is a right side elevation thereof; FIG. 9 is a top plan view of a game machine in accordance with a second embodiment of our new design; FIG. 10 is a rear elevation view thereof; FIG. 11 is a bottom plan view thereof; FIG. 12 is a front elevation view thereof; FIG. 13 is a left side view thereof; FIG. 14 is a right side view thereof; FIG. 15 is a top left front perspective view thereof; and FIG. 16 is a top right rear perspective view thereof.

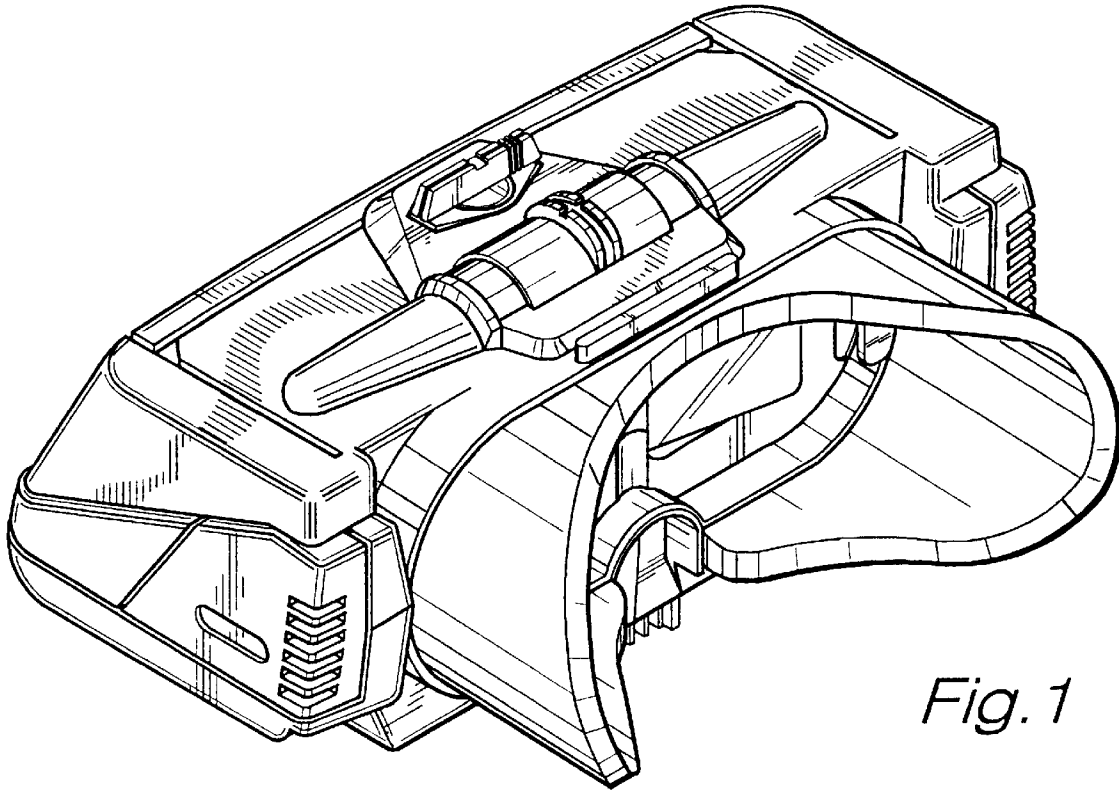

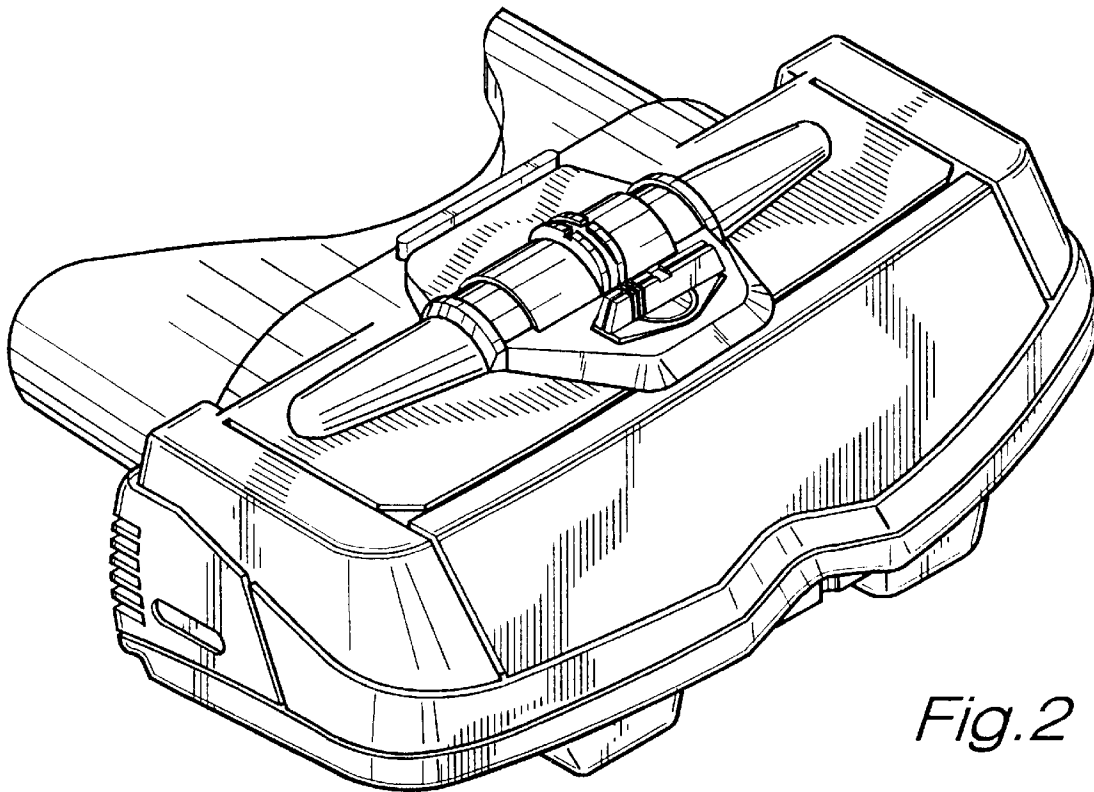

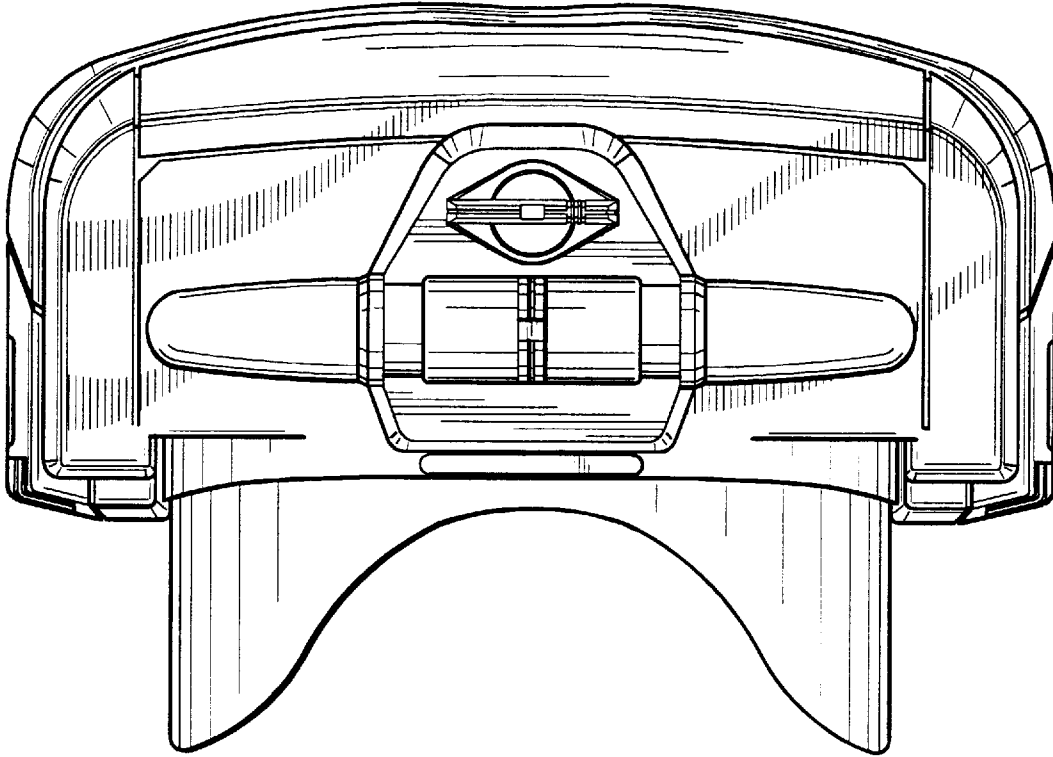

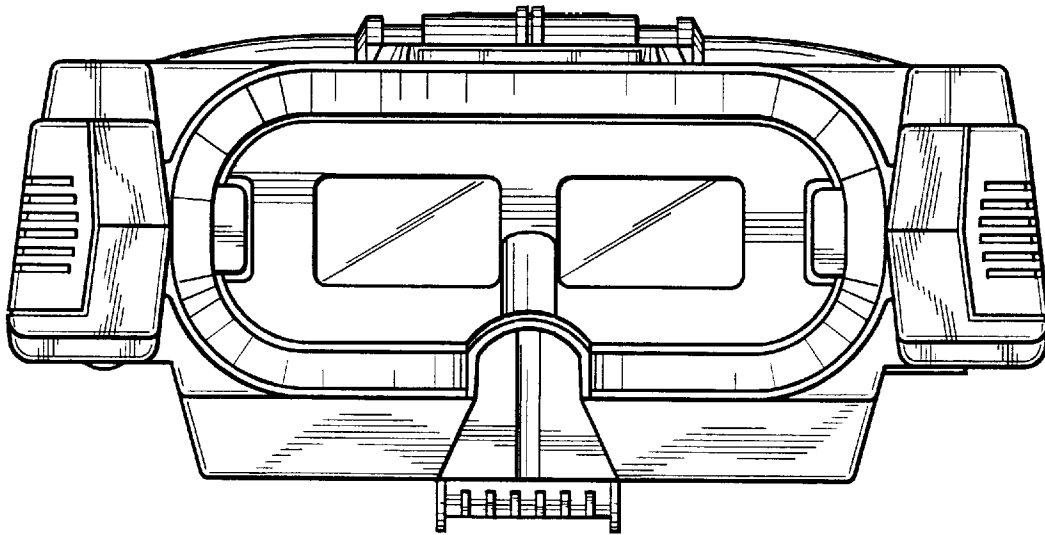

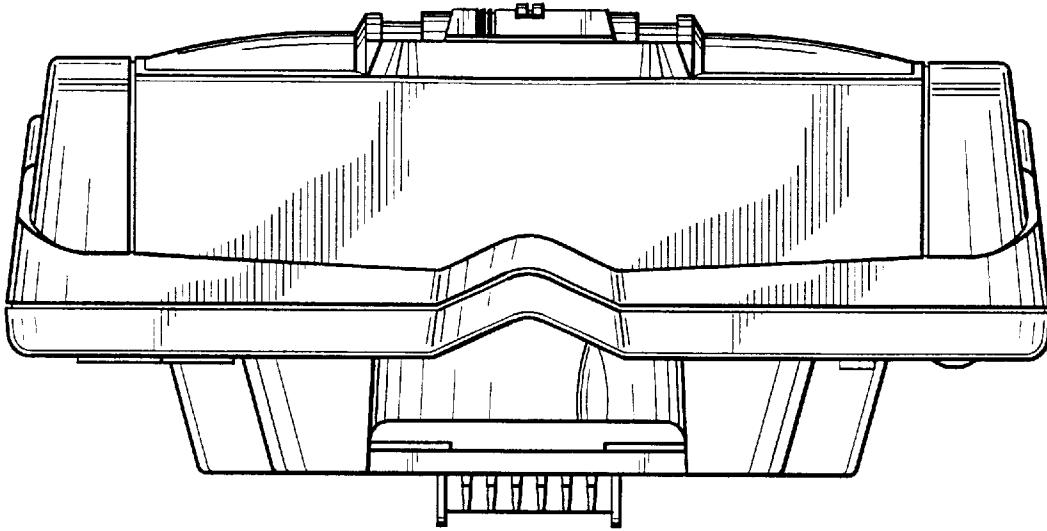

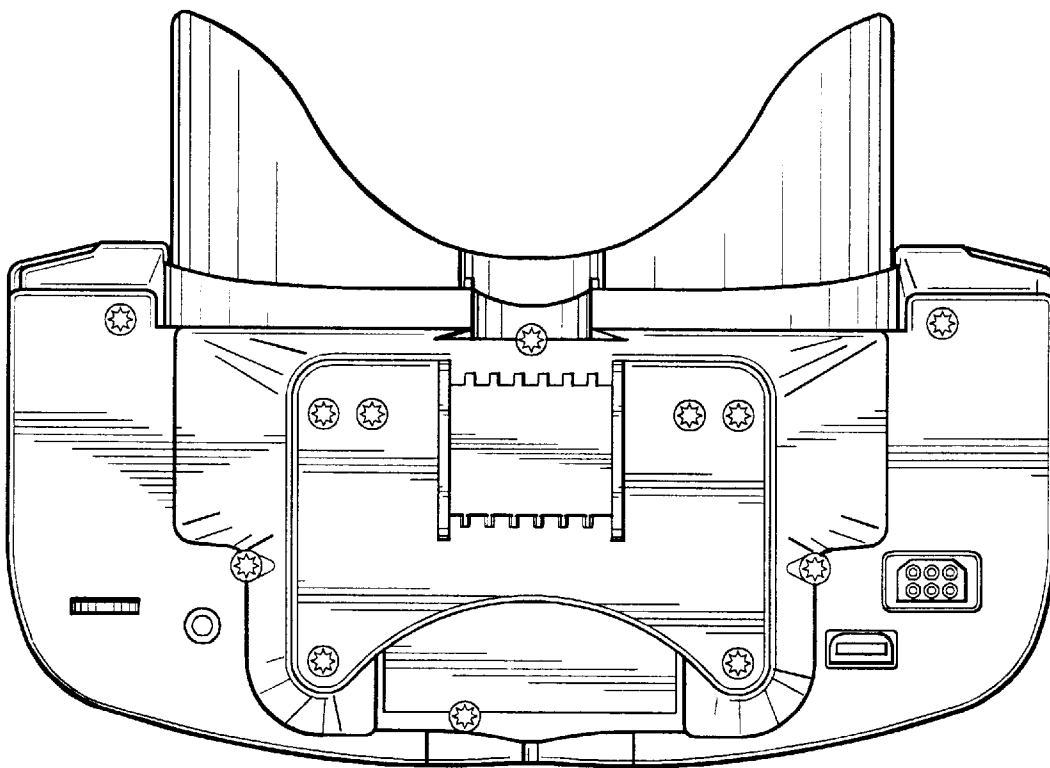

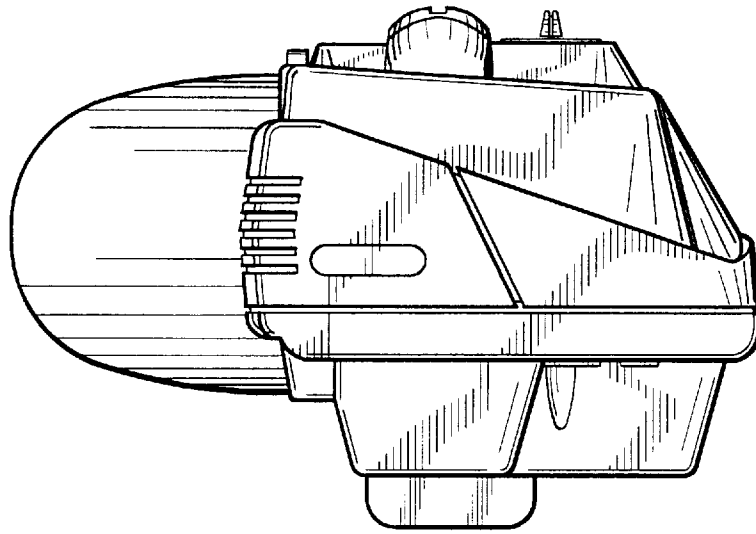

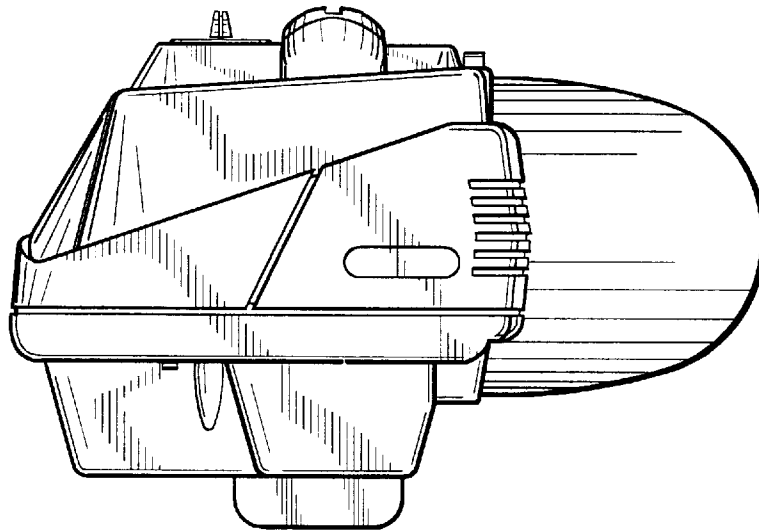

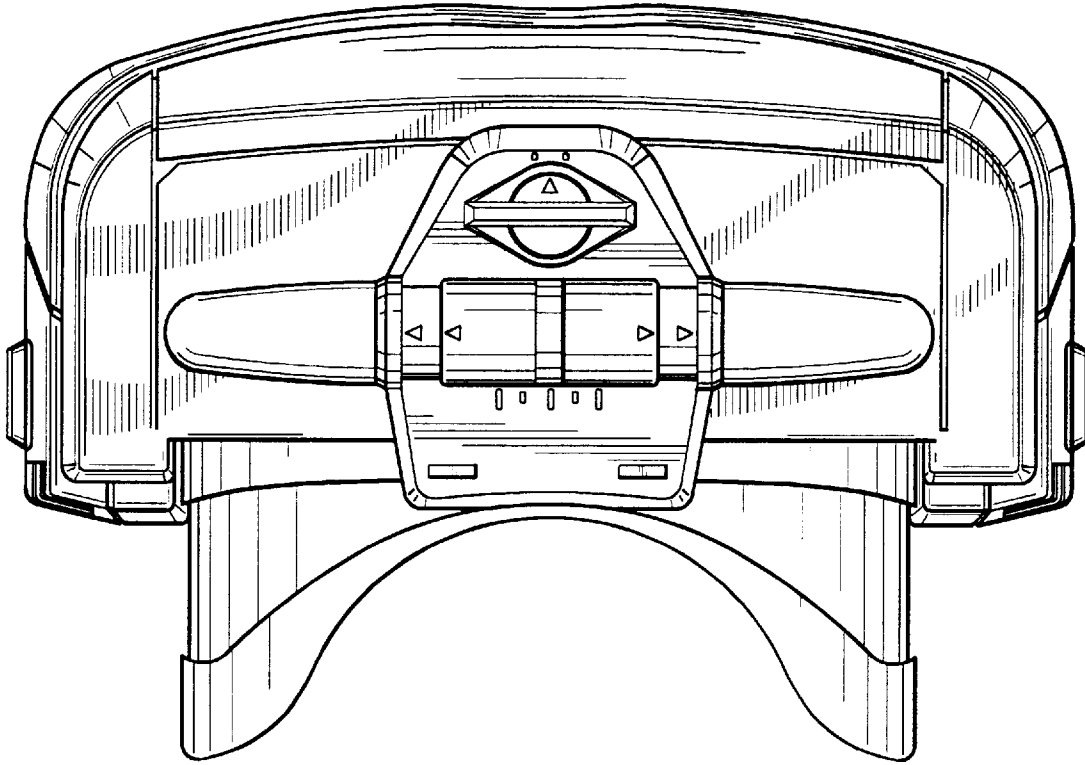

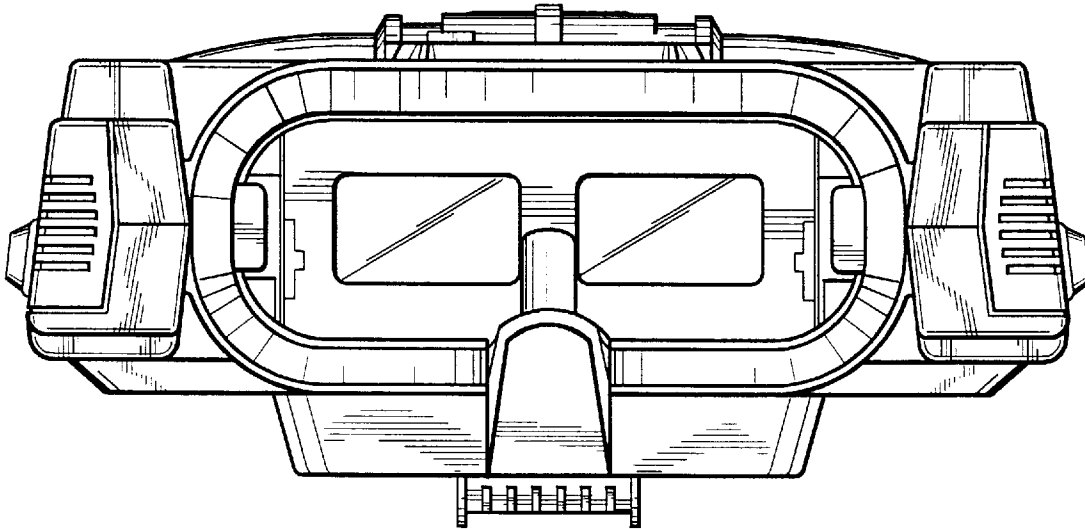

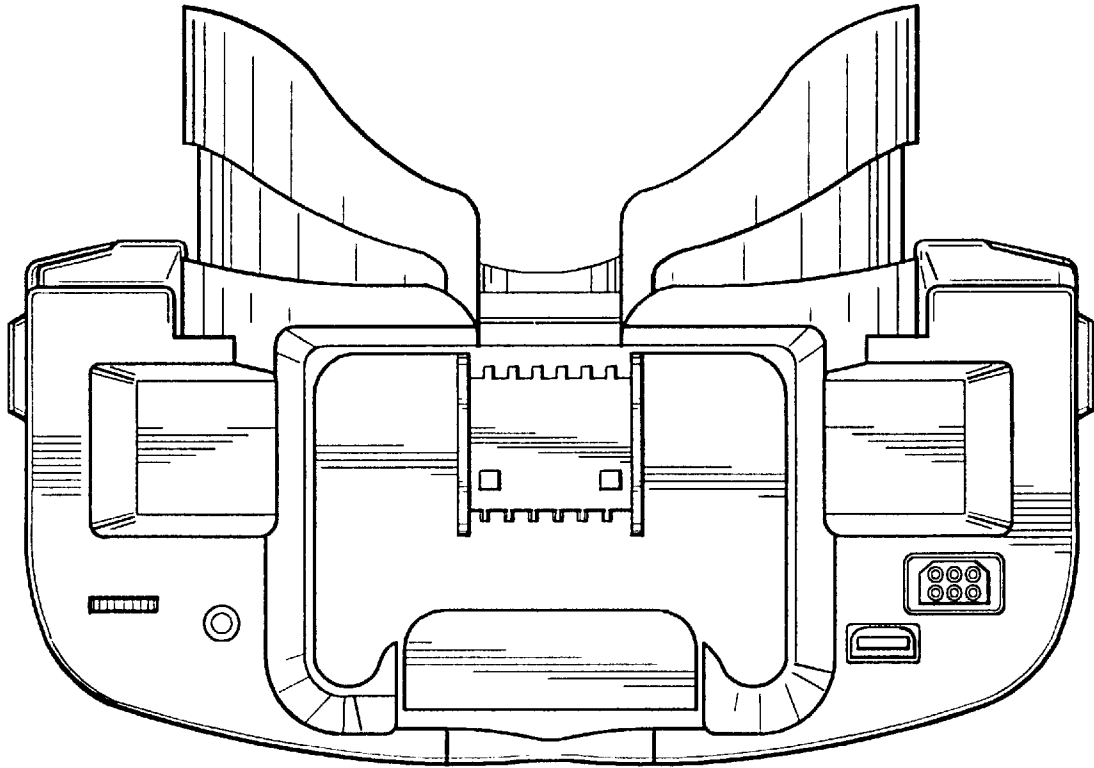

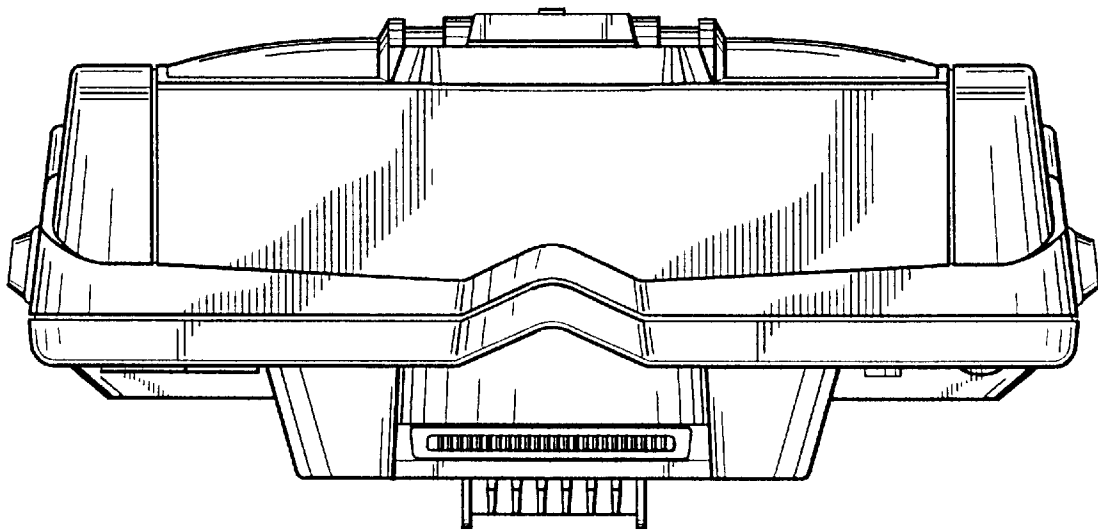

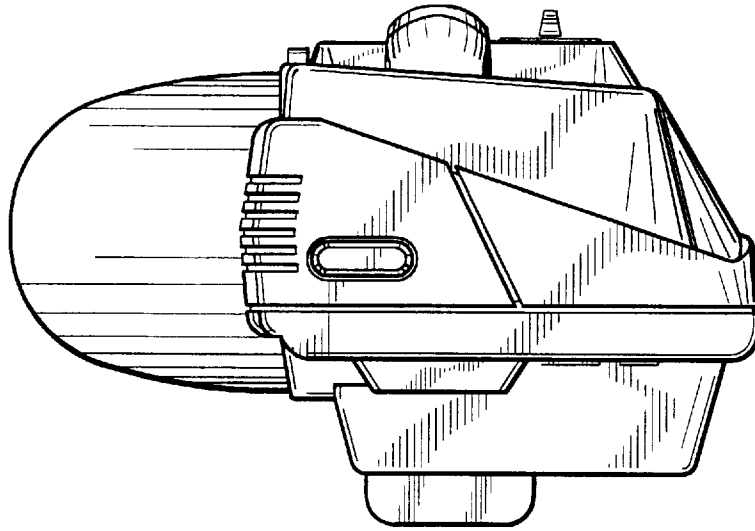

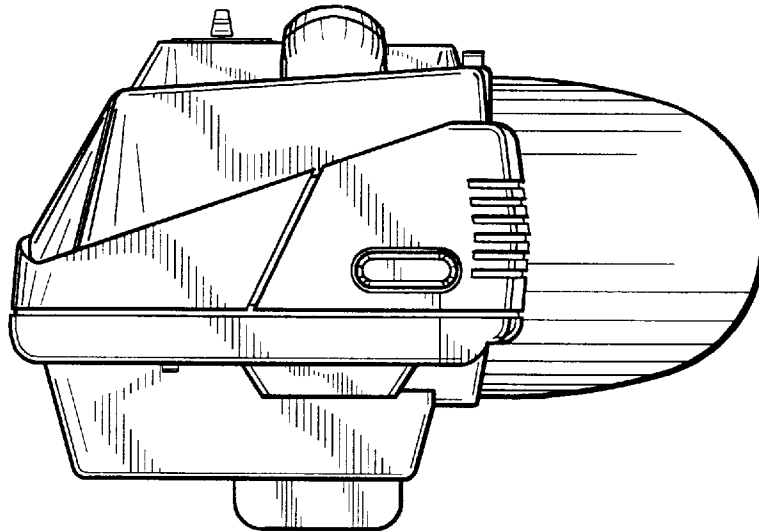

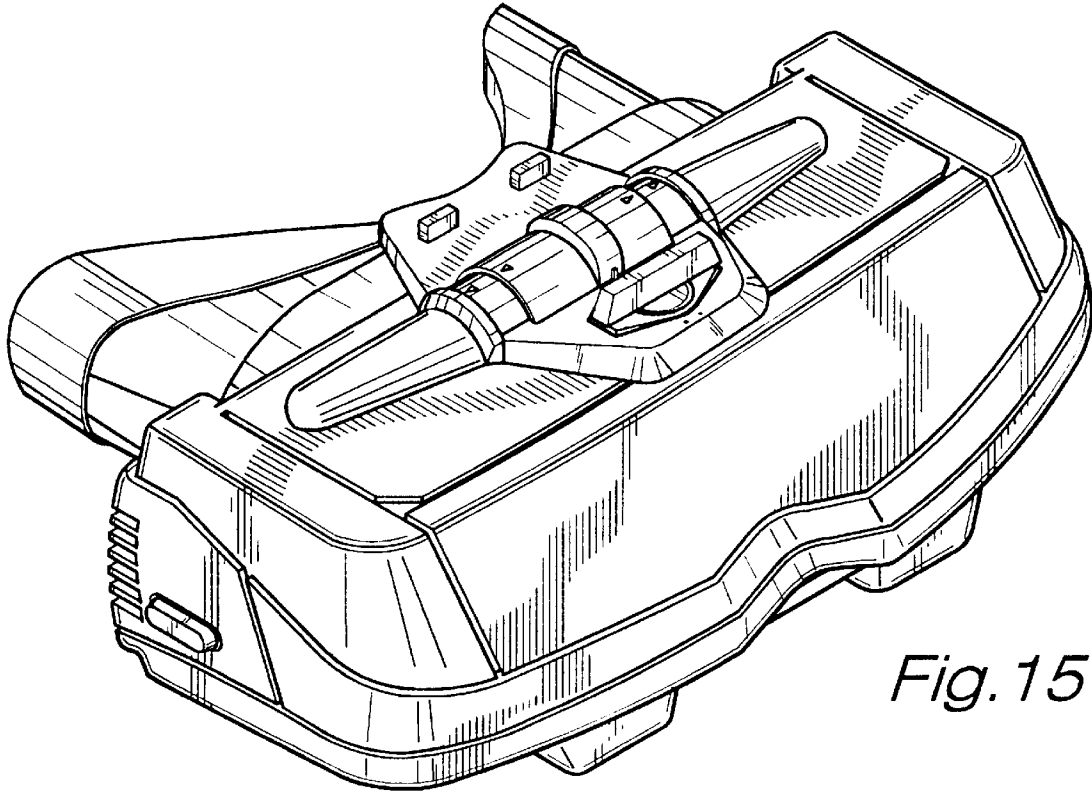

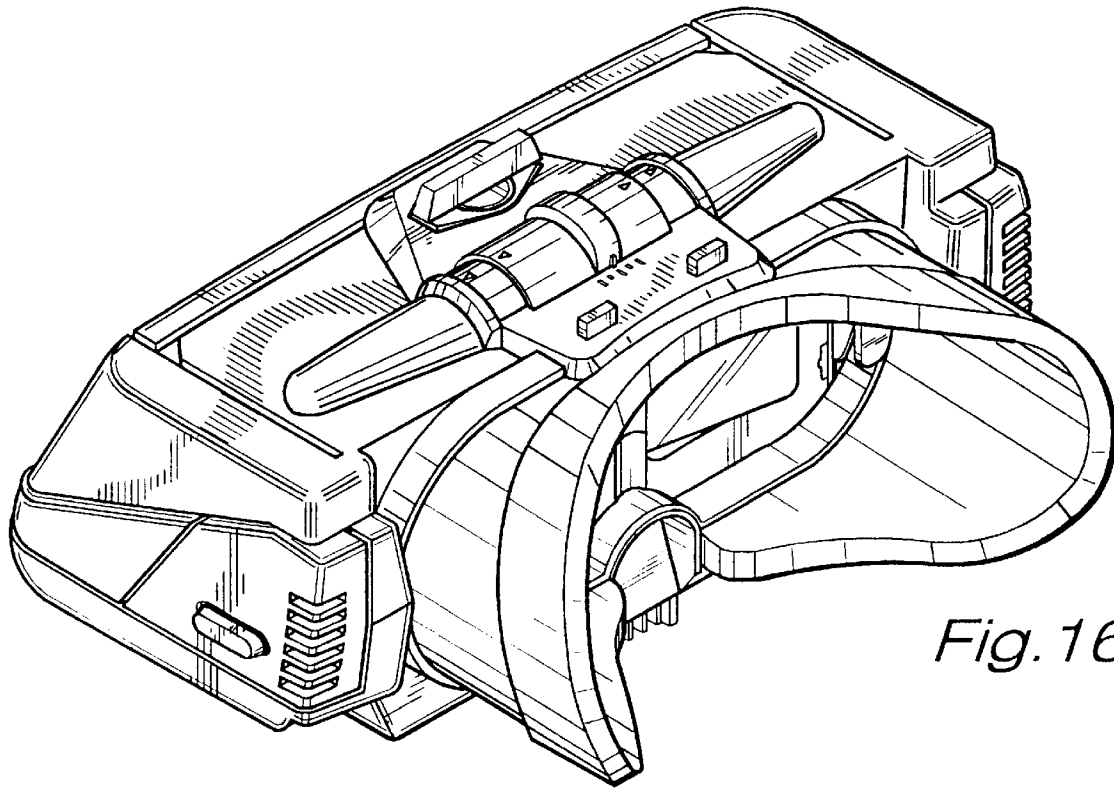
